Packages may be upgraded at any time during the contract, but would require the difference in installation cost to be paid. I understand that it is my responsibility to purchase the appropriate ADSL modem and related equipment for my computer system or network and ABCOMM must approve the ADSL modem and related equipment for use on its system. It is fully my responsibility to have all ADSL equipment operational prior to the ADSL connection. Abcomm reserves the right to configure any ADSL related equipment for use on their network. It is my responsibility to have a telephone jack for the ADSL service near my computer or workgroup hub, and that any extra wiring that will be required is not the responsibility of ABCOMM.

I/We authorize ACSL to automatically debit my credit card, once per month in advance of that month's access charge, plus any additional costs incurred in previous months, in excess of the fixed package flat rate, such as excess traffic charges. I understand that I will be charged the minimum access fee regardless of usage during any given month.
